Response to Resistance: Good tactics are vital to law enforcement officers in their efforts to keep our communities safe, but they are just the beginning. This course will provide officers with a greater understanding of use of force case law, allowing them to more effectively recognize the legally significant factors present when responding to resistance. After taking this class, attendees will also better comprehend the impact of stress on human performance, and both the value and limitations of body-worn cameras.



Course Introduction - 10 minutes

Instructor introduction.

- 1) Explain the course objective.
 - a) Define what actions are permissible with use of force.
 - b) Learn how to articulate reasons for use of force.
 - c) Identify a seizure under the Fourth Amendment.
- 2) Encourage attendees to ask questions and share feedback with other attendees.
- 3) Explain that certificates will be emailed after the class and each student will be registered in the Blue to Gold University.
- 4) Go over the three disclaimers:
 - a) Laws and agency standard operating procedures may be more restrictive. Blue to Gold teaching the federal standard unless otherwise stated. Therefore, students must know their state and local requirements in addition to the federal standard.
