### Search & Seizure Workshop (2 Day Course)

This 2-day program presents a unique instructional method to reinforce learning about critical constitutional policing matters. Rather than the passive learning method associated with a traditional lecture-based training class, this program encourages, in fact requires, each student to be an active participant in the learning process. The instructor will actively guide the discussions through thought-provoking questions and counterarguments. At the end of each discussion session, the instructor will provide the proper doctrinal underpinnings, supported by the relevant caselaw, for the appropriate resolutions to the questions presented in the scenarios. Helping officers avoid the likelihood of evidence suppression and reducing individual and organizational liability exposure.

Some issues covered:

- Which areas and interests receive Fourth Amendment protection
- How to assess the reliability and utility of information received from informants
- The nature of reasonable suspicion and probable cause
- The scope of, and basis for conducting, searches incident to arrest
- The grounds for warrantless entry into residential premises
- Distinguishing between “curtilage” and “open field” designations of real property
- Application and limitation of the plain view doctrine of warrantless seizure
- The validity and scope of consent searches
- The contours of the automobile exception
- Defining the “custody” and “interrogation” requirements of the Miranda rule
- And much more!
