### Mastering Search & Seizure

This course gives officers a deep dive into search and seizure law, with a focus on real-world application in a variety of policing situations. Building on lessons from Blue to Gold's Advanced Search & Seizure and Advanced Traffic Stops courses, you'll also tackle important topics like community caretaking and the emergency aid exception. Whether it's a consent search or a warrantless vehicle search, you'll learn how to make solid, defensible decisions that protect your case—and your department.

### Interview and Interrogation Case Law

This course helps officers master the legal principles that govern interviews and interrogations, focusing on the Fifth and Sixth Amendments so you can gather evidence that's both solid and admissible. You'll learn about Miranda rights—where they came from and how they apply on the street—including when someone is considered “in custody,” what counts as interrogation, and how to secure a valid waiver. The course also tackles more advanced topics like how to resume questioning legally after a suspect invokes their rights, how to fix mistakes, and how special rules apply to juveniles. We'll also cover the Fruit of the Poisonous Tree doctrine and what happens in non-criminal settings like administrative interviews.

### Bulletproof Report Writing

This course gives officers the tools to write clear, detailed reports that stand up to legal scrutiny and support successful prosecutions. You'll learn how to put your observations and actions into words that make sense to judges, prosecutors, and defense attorneys alike. From explaining probable cause to describing what you saw and did, you'll build the skills to write reports that are thorough and easy to follow. The course also shows how solid documentation can discourage suppression motions and help you recall key details when testifying in court.
