### Advanced Search & Seizure

We'll cover both federal and state cases to make sure you're ready no matter where you work. ### Advanced Traffic Stops

Making a traffic stop is one of the most common—and sometimes most legally tricky—things cops do. You'll learn the nuts and bolts of key traffic stop topics—like the motor vehicle exception, pretext stops, vehicle searches, and passenger questioning. We'll also cover the big court decisions that shape how you do your job, and dig into things like K9 sniffs, inventories, and probable cause searches.

From explaining probable cause to describing what you saw and did, you'll build the skills to write reports that are thorough and easy to follow. The course also shows how solid documentation can discourage suppression motions and help you recall key details when testifying in court.
