Advanced Search & Seizure

Knowing when and how to conduct a search or seizure is a critical part of good police work. This course breaks down the Fourth Amendment and how it applies on the street, giving officers the tools they need to make solid, defensible decisions in the field. Advanced Traffic Stops
