### Advanced Criminal Investigations (26CPT590)

You'll learn about complex legal issues that come up in major cases—like search warrants, managing informants, and working in high-risk environments. The course highlights the importance of knowing the law inside and out so that your work is solid in court. You'll also learn practical ways to handle arrests, searches, and other challenges without getting tripped up by technicalities.

### Interview and Interrogation Case Law (26CPT679)

You'll learn about Miranda rights—where they came from and how they apply on the street—including when someone is considered “in custody,” what counts as interrogation, and how to secure a valid waiver. The course also tackles more advanced topics like how to resume questioning legally after a suspect invokes their rights, how to fix mistakes, and how special rules apply to juveniles. We'll also cover the Fruit of the Poisonous Tree doctrine and what happens in non-criminal settings like administrative interviews.

### Real World De-Escalation & Duty to Intervene (26CPT084 & 26CPT085)

You'll learn about the legal requirements and department policies that spell out the duty to intervene, and why it matters. The course also covers the serious consequences of failing to act, including discipline, lawsuits, and even criminal charges.
